



**Purpose:** The purpose of this League is to provide a football program for sixth, seventh and eighth grade students and promote interest in football for the respective high school districts. The League will promote and encourage a spirit of good sportsmanship and fellowship among its members, develop a greater civic pride in football, and encourage the building of development of useful and worthwhile citizens from its participants, both coaches and players. The League urges all members to educate and prepare all participants concerning the “No Pass-No Play Rule” that is used in Georgia High School Associations.

**Requirements:** Players must meet age and residency requirements to play. Failure to adhere to the age and residency requirements will result in forfeiture of games in which an ineligible player was a member of the team.

**There is no minimum playing time for games but all participants should receive equal or near equal practice time.**

### Waiver

I further state that I shall not hold any person, firm or corporation backing any team, nor any of the officers or coaches of the NORTH GEORGIA FOOTBALL LEAGUE, INC. responsible or liable for injuries incurred during practice sessions, practice games, regularly scheduled games or while being transported to and from same.

I further certify that by placing my signature on this document, I have been served with notification that the NORTH GEORGIA FOOTBALL LEAGUE, INC. *does not* carry any insurance on my child. As parent/guardian, I am responsible for any medical bills incurred while my child participates in activities of the NORTH GEORGIA FOOTBALL LEAGUE, INC.

I further certify that the information given on the registration form is correct. I do give my child's school \_\_\_\_\_ permission to release information regarding age, residence address and/or recognized parent or legal guardianship to a representative of the NORTH GEORGIA FOOTBALL LEAGUE, INC.

The terms of this WAIVER are in force from the date of this registration for a full year.

If any provision of this agreement shall be held to be illegal, invalid, or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.
